## Terms of Use

### SCHEIBERSPACE Websites and Web Content

This site is operated and maintained by private individuals, located in Vienna, Austria. In the following, the website owners and operators are referred to as <u>SCHEIBERSPACE Operators</u>.

These Terms of Use shall apply to all SCHEIBERSPACE websites and portals, including but not limited to

## Users of Web Content

Alternatively, if parties agree, a recognised European International Arbitral Center can be accepted for the settlement of disputes.

In the absence of a suitable legal aid agreement between the state of Austria and the state where the User is located, SCHEIBERSPACE Operators reserve the right to change the place of court to the state or economic region where the User is located or registered.

You agree that SCHEIBERSPACE Operators may provide you with notices, including those regarding changes to the Terms of Use, by e-mail or postings on SCHEIBERSPACE Websites.
